## NOTIFICATION

It is hereby notified that in 511<sup>th</sup> Board Meeting of the BISE Lahore, dated 29.06.2022 vide item No.18-C, the House after detailed deliberation and discussion approved the following decision of the Punjab Boards Committee of Chairpersons (PBCC) made in its meeting held on 30.03.2022 regarding Unbundling of Scheme of Studies from the Academic Session 2022-23 and decided as given below:-

SN	Existing Rules	Approved Rules
1	A candidate, who has qualified for grant of the SSC/HSSC or an examination recognized as equivalent thereto, may appear on prescribed fee and form in any subsequent examination, in a subject or subjects, not offered by him/her previously, before taking higher examination, in the same Board from where he/she has passed SSC/HSSC examination. Such a candidate shall on passing the relevant subject/s in the same sitting be granted a certificate to that effect i.e. additional subject/s. Moreover, if the candidate appeared in more than one subject he/she must pass all the subjects in the same sitting. Provided that on qualifying an additional subject/s will not be allowed to improve marks.	A candidate may appear in any number of additional subject/s along with his/her group of subjects already opted at SSC/HSSC level in the same Board from where he/she appeared in the SSC/HSSC examination. To qualify the additional subject/s a candidate may avail the same number of attempts as available for the regular candidate to qualify the said examination.
2	A candidate desirous of appearing in the subject of Biology or any other subject having practical shall take admission in affiliated institution as regular student, attend classes and perform practical in laboratory. Institutions shall forward his/her registration and admission as regular student. However, the candidate shall appear in both papers i.e. part-I and Part-II in very next annual examination in the current course not offered by him/her previously.	A candidate desirous of appearing in the subject(s) at the level of HSSC examination having practical shall take admission in affiliated institution as regular student, attend classes and perform practical in laboratory. Institutions shall forward his/her registration and admission as regular student. However, the candidate shall appear in both papers i.e. part-I and Part-II in 1 <sup>st</sup> annual and 2 <sup>nd</sup> annual examinations in the current course not offered by him/her previously.
