NOTIFICATION

It is hereby notified that in 518th Board Meeting of the BISE Lahore, dated 29.08.2023 vide Table item No.2, the House unanimously approved to amend the marks improvement rules for SSC & HSSC Examination vide Notification No.679/SY/PBCC/LHR dated 24-05-2023 given below

1	For the purpose of improving marks/ grades, candidates will be provided four examination opportunities in the current prevalent syllabi in the same subjects/ group in which he previously passed the examination. The chances can be availed within a period of two years of having passed SSC and Intermediate examination, provided that the chances must be availed before appearing in any higher examination conducted by any examining Body
3	The candidate may appear in following categories: (a) In subjects(s) of his choice (subjects means Part-I+ Part-II+ Practical) (b) In Part-I (c) In Part-II (d) In part-I and Part-II both The old posting should be taken from the last improved result

Later, for making some amendments in Clause (2) of the said rule, the matter was again placed before the PBCC in its meeting dated 18th May, 2023 which decided by adding the following:

"(e) The candidates can improve either Part-I, Part-II or Practical"

As the above decisions were taken in different meetings of PBCC, therefore, the following ones regarding marks improvement for SSC and Intermediate decisions regarding marks improvement for SSC and Intermediate examinations may please be allowed to be placed as agenda item in next meeting of BOG for approval:

For the purpose of improving marks/ grades, candidates will be provided four examination opportunities in the current prevalent syllabi in the same subjects/ group in which he previously passed the examination. The chances can be availed within a period of two years of having passed SSC and Intermediate examination, provided that the chances must be availed before appearing in any higher examination conducted by any examining Body

2 The candidate may appear in following categories: (a) In subjects(s) of his choice (subjects means Part-I+ Part-II+ Practical)

(b) In Part-I (c) In Part-II

(d) In part-I and Part-II both

(e) In any paper(s) of part-I or part-II

(f) The Candidate can improve either part —I, part-II or Practical

The old posting should be taken from the last improved result, so that increased marks in any subject(s) could be posted in the result.
