

**ADVERTISEMENT OF EXPRESSION OF INTEREST (EOI) FOR PREQUALIFICATION  
OF CONTRACTORS FOR THE PROJECT "SOLARIZATION OF BOARD OF  
INTERMEDIATE & SECONDARY EDUCATION (BISE) LAHORE"**

- i. Board of Intermediate & Secondary Education, Lahore has a vision to energize its buildings to solar power. Through this program, BISE Lahore intends to create awareness amongst the general public for the use of Alternate Energy Resources to reduce dependency on the national grid and to improve the environmental conditions of the province. As per this vision, BISE Lahore intends to install a 495 KW solar PV Plant on its Rooftops.
- ii. For this purpose, the BISE Lahore has decided to prequalify the eligible bidders/contractors through Competitive Bidding for the procurement, supply, construction, installation, testing, and commissioning of the project "SOLARIZATION OF BOARD OF INTERMEDIATE & SECONDARY EDUCATION (BISE) LAHORE". The firm will be hired for the said assignment as per provisions of the Punjab Procurement Regulatory Authority (PPRA) Rules 2014.
- iii. National & International Companies/Joint Ventures/Consortium Partners fulfilling the terms & conditions and evaluation criteria as mentioned in this Pre-Qualification Document (PQD), may submit their EOI on prescribed formats for Pre-qualification for the said project at the address given below. **The Opening date for submission of EOI is till 08 July 2023 at 02:00 P.M (PST). The EOIs shall be opened publicly by the notified Committee on the same date i.e. 08 July at 2:30 P.M (PST), in the Office of the Deputy Secretary Stores, in the presence of the bidders or their representatives who may choose to attend the EOI opening meeting.**
- iv. The interested bidders may obtain a signed copy of PQD immediately available after publication of the tender in National Press (Newspapers) and uploading of Tender on PPRA Website from Store/Procurement Section during office hours till 07-07-2023 on production of original deposit slip of prescribed fee paid in HBL BISE Lahore Branch. (in the English language) on a written request from the office on the below-mentioned address at the cost of Rs. 10,000/- (Ten Thousand only Non-refundable) during the office working hours from the date of publication of this advertisement up to one day before the closing day.
- v. Copy of the un-signed PQD is also available on the websites of BISE Lahore ([www.biselahore.com](http://www.biselahore.com)) and PPRA ([www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk)). The EOIs of those bidders shall only be acceptable who shall purchase PQD from the Procuring Agency. No photocopy, self created documents of any area other than provided by the Procuring Agency shall be accepted.
- vi. The written queries relating to PQD received from bidders minimum 03 days before the closing date would be responded to through emails.
- vii. EOIs shall be evaluated as per Punjab Procurement Rules, 2014. Only the prequalified bidders under this process shall be invited to submit the technical & financial bids.
- viii. The procuring agency reserves the right to reject all EOIs under the provisions of PPRA Rules, 2014.
